Delivery Instructions for Gifting of Securities

Notification and coordination

Valuation and Acknowledgement of your Gift

The value of the gifted security is the Fair Market Value (FMV) on the valuation date. If there is an active market for the contributed stocks or bonds on a stock exchange, in an over-the-counter market, or elsewhere, the FMV of each share or bond is the average price between the highest and lowest quoted selling prices on the valuation date. For example, if the highest selling price for a share was \$11, and the lowest \$9, the average price is \$10. You get the average price by adding \$11 and \$9 and dividing the sum by 2. (IRS Publication 561) You will receive an acknowledgement letter to use for tax purposes along with the stated valuation of the gift and confirmation that your gift will be in support of the campaign.
